

2018 Health Savings Account Index Figures

The IRS released the inflation-adjusted contribution and related amounts for health savings accounts (HSAs) and HSA-compatible high deductible health plans (HDHPs) for 2018. These amounts are tied to changes in the Consumer Price Index by application of the cost-of-living adjustment rules. The amounts for 2018 are set forth below:
